- Is a joint project of the MDJA and Lawyers Concerned for Lawyers.
- Is absolutely confidential.
- Provides telephone access to counselors 24/7.
- Provides assistance with addiction, mental health, stress and other work life issues such as aging, family, financial and career concerns.
- Allows you or an immediate family member to receive up to 4 free counseling sessions and referrals to appropriate community resources for additional assistance.

- Provides guidance on work/life situations.
- Provides access to peer assistance, both through the MDJA and LCL.
- Can be a place to get personal support when facing ethical conduct issues.

WHY WOULD A JUDGE CALL LCL AND WHAT HAPPENS WHEN YOU DO?

- ✤ Judges Helping Lawyers
 - The judge is often the most effective intervener
 - The judge's authority, when used correctly, can motivate the lawyer to acknowledge a problem substances, cognitive impairment, mental health, anger, etc.
 - The judge can point out that continued difficulties could lead to disciplinary problems
 - Sometimes a judge is reluctant to get involved *but* can make a real difference
 - It's a personal issue or "none of my business
 - Concern about getting the lawyer in disciplinary trouble
 - Potential for re-election implications
 - LCL can still help if the judge remains anonymous
- ✤ Judges Helping Judges
 - One judge helping another may be the most effective technique
 - o Judge who has "been there" can address denial and fears
 - Easier to talk to peer
- ↔ Why are Judges Reluctant to Ask for Help Themselves?
 - Concern with anonymity
 - o Denial
 - o Fear
 - Terminal uniqueness
 - \circ Isolation
 - Embarrassment
 - Hopelessness
- The Judge's Role
 - Understanding indications of impairment
 - Judge may be the first authority figure to recognize impairment in a lawyer or another judge
 - Due to their status, judges can be extremely effective in reaching out to a lawyer or judge they are concerned about
- ↔ When someone contacts LCL, everything is **confidential**.
 - LCL's response fits the situation:
 - Information and coaching on how to reach out and discussion of options and resources
 - Contact from LCL volunteers (judges help judges) *only with permission*
 - Additional coaching
 - Assisting with outreach
 - Telling their story
 - Assistance with interventions
 - Crisis response
 - LCL's services are free and a counselor is available 24 hours a day.
 - Information on judges is recorded with a code, not names.
