## 4. Client Activity

LCL helped 33 new clients in December. We assisted 7 people with substance use issues and 18 presented with mental health issues (including some overlap). General stress and career issues were the most common personal concerns. We assisted 21 men and 12 women. We helped 27 lawyers, 3 judges, 2 law students, and 1 family member.

LCL's Family, ADHD, Careers, and Well-Being groups met remotely, along with a parenting group we are facilitating for Minnesota Women Lawyers. LCL's Discipline group met in a hybrid format. Groups that normally would have met between Christmas Eve and New Year's Day did not meet that week. LCL also hosts a weekly open 12-step group. We do not include the 12-step group attendance in our monthly group attendance reports as it is not an LCL "sponsored" group.
